**Treasurer's Report -** Brion presented the 2021 treasurer's report. Good year financiallywith an \$8,000 surplus. Spent \$164,000 on expenses, \$12,000 on M&S,and \$25,000 from fund balances, for a total of \$200,000. The draft budget shows a shortfall of \$25,000. Expenses projected to be the same as last year, but anticipated revenue is projected to be less. Discussion – Bob Crowley - budgets are based on programming of the church – mission, values, vision. Congregation must support programs that define who we are. Barb McBean - not surprised expect every year to hear we need money. Chris Young – we need to be innovative in revenue and fundraising ideas. Bill Whittaker – cautioned that many members are on fixed incomes. Sally Allanach – we may possibly need a part-time maintenance person. Rev. Richard – when presenting at the AGM suggested showing a breakdown of cost per member to manage the shock factor. Cindy Millican – agreed with the thought that the presentation of shortfall is important.

## Brion moved acceptance of a \$171,000 budget, with a potential deficit of \$25,000 for presentation to the congregation at the AGM. Bill Whittaker $2^{nd}$ . Carried.

Sue King moved that council create a new Affirming Committee, reporting to council, to continue the work of Affirm United. Diane Tonge 2<sup>nd</sup>. Carried.
